

Go North R.V. Rental Terms & Conditions

- **ALL units are non-smoking and pet free.**

BOOKING & DAMAGE DEPOSIT

1. **ALL** booking is done by telephone or at the office.
2. A \$400.00 booking deposit is required to reserve a unit and payment can be made by: Visa, Mastercard, Interac, or Cash. (The \$400.00 booking deposit is subtracted from the rental total at departure time).
3. An \$800.00 damage deposit is required at departure time and can be paid either by Visa preauthorization, cash, or Interac. (This \$800.00 will be reimbursed when the unit is brought back in good, clean condition. If the renter chooses to have Go North R.V. Rental do the cleaning, additional charges may be issued including: \$45.00 to clean the inside, \$45.00 to clean the outside, and \$75.00 to dump the sewage).
4. Booking dates **CANNOT** be changed at departure time (if you have booked for 5 days, you will be charged for 5 days). Also, if you would like extra days, phone ahead as soon as possible and **Go North R.V. Rental** will do its best to accommodate your needs.

CANCELATIONS

Our business is built on firm booking therefore the \$400.00 booking deposit is **non-refundable** if cancelled within 30 days of departure. If you cancel over 30 days before departure, a cancellation fee of \$75.00 will apply.

DEPARTURE PICK-UPS

ALL pick-ups **MUST** be made Monday – Friday, **Go North R.V. Rental** does its best to be very flexible in order to accommodate your pick-up needs. You must call the day before pick-up to arrange a pick-up time in order to ensure no wait time at Go North R.V. Rental yard.

DROP-OFFS

Drop-offs can be done at **Go North R.V. Rental** yard at any time before 6:00pm on return date, just call ahead and let the **Go North R.V. Rental** rep know when drop-off will be made (phones are answered 24hrs a day during July and August. If no answer, leave a detailed message and a Go North Rep will return your call at their earliest convenience).

(Any late returns will be charged for the rental fees lost due to late returns).

TOW VEHICLE

1. Tow vehicles **MUST** be equipped to tow 5500 lbs for our smallest units and 7500 lbs for our largest units.
2. Tow vehicle **MUST** be equipped with a “factory approved” hitch with appropriate tow rating.
3. Tow vehicles **MUST** have proper 7-pin plug and electronic brake control.
(Go North R.V. Rental will supply 2-5/16 inch ball hitch with stabilizer bars if necessary.)

Insurance & Liability

- This form **MUST** be signed at the time of departure.
- In most cases, liability insurance is assumed by the tow vehicles insurance policy. Renter should check with his/her insurance company in order to make sure that they assume liability.
- **ALL** renters **MUST** be at least 21yrs of age and possess valid insurance on tow vehicle.
- [Go North R.V. Rental](#) assumes the collision portion of insurance and has a \$2000.00 deductible.
- In case of a collision, **ALL** collisions **MUST** be reported to police and [Go North R.V. Rental](#) within 24hrs of the incident. (Insurance may be null & void if not reported).

Deductible may be reduced for an additional charge

- \$25.00 a day for a \$500.00 deductible.
- \$20.00 a day for a \$1000.00 deductible.
- \$15.00 a day for a \$1500.00 deductible.

(The renter assumes ALL liability for damages incurred while in the care and control of the trailer).

The renter has read and understood the Terms & Conditions. The renter has also supplied [Go North R.V. Rental](#) with a valid credit card number, which can be used for any extra charges incurred by the renter, including insurance deductibles.
